#### LEGISLATURE MAKES PROGRESS ON CHILD PROTECTION MEASURES

The 2021 Minnesota State legislative session is expected to adjourn on May 17th. While final outcomes are not yet known, progress has been made on a number of important issues.

Safe Passage for Children of Minnesota's 2021 bill would require counties to: a.) Interview children separately from and prior to adults during the initial visit, b.) Interview foster children over four years old separately from foster parents, c.) Stop giving parents advance notice of child protection visits, d.) Train child protection workers in fact-finding before assigning cases to the investigative or Family Assessment track, and e.) Put information in case notes, providing a reference for future workers who may investigate the same children and families. The bill did not get a hearing in 2021, but we succeeded in getting it introduced in both the House and the Senate. Chief authors are Sen. Julie Rosen (R-Fairmont) and Rep. Heather Edelson (DFL-Edina), with House co-authors Rep. Kaoly Her (DFL-Saint Paul) and Rep. Jamie Becker-Finn (DFL-Roseville). The bill received support from seven members of the Persons of Color and Indigenous (POCI) Caucus;

three of whom offered to also co-author the bill. Their names can be added in the 2022 legislative session.

The case for this legislation has become stronger over the past year. Thirteen states have ended the practices recommended in our bill due to high profile child fatalities. Although research indicates that no more than 33% of cases be referred to programs for low risk cases like Family Assessment, in Minnesota that figure is 62%. Several national experts are currently working with Safe Passage to promote this legislation, and with the help of our volunteers we believe we have a realistic prospect of getting it passed in 2022.

In addition Safe Passage is supporting an important foster care licensing bill which was developed by the Center to Transform Child Protection at Mitchell-Hamline Law School with support from many other organizations as well. Safe Passage worked with the Center to help get hearings in the Senate. The measure removes numerous felonies as automatic barriers to becoming a licensed foster parent, substituting instead a consistent process for evaluating prospective caregivers. These criteria help address the disproportionate impacts of arrests and prosecutions on people of color. The measure will enable applicants for foster care licenses to be more objectively evaluated according to their ability to parent a child. As of this writing the bill has reached the floor of the Senate for a vote and is included in the omnibus Health and Human Services bill in the House.

Speaking of volunteering, a celebration is in order! As you may know, we are finishing up our annual spring child advocacy events at the Minnesota state capitol. This year, because of the coronavirus, instead of visiting the capitol in person, we successfully hosted several ongoing and safe Virtual Child Advocacy Weeks during February and March 2021. To make this a successful effort for our volunteers, we provided free online training for all volunteer child advocates to prepare to meet with their state legislators to learn about our legislative work and how to meet with their legislators. We also provided almost 24/7 support connecting volunteers with their legislators, with the goal of setting up one-on-one meetings coordinated with our volunteers' and their legislators' schedules.

Though we had never held a "virtual" child advocacy event before this year, it was a resounding success for both our volunteer child advocates and for our communications with legislators! 39 of our energized and compassionate Safe Passage volunteer child advocates from many of Minnesota's districts met with their state legislators during our Virtual Child Advocacy Weeks. Minnesota state legislators around the state enjoyed many opportunities to learn from our volunteers about the current challenges facing abused and neglected Minnesota children, and they learned how their legislative voice and vote could help improve the lives and the futures of Minnesota's most vulnerable children.

#### WEBINARS OFFER RESOURCE ON CHILD PROTECTION AND FOSTER CARE

In April 2020 Safe Passage for Children initiated a biweekly webinar on matters related to child protection and foster care. The attendance has grown significantly for most sessions, with peaks at 45 or 50 participants for panel discussions and presentations by national experts. Many of these webinars have showcased outstanding programs or agencies in Minnesota, such as CornerHouse, St. David's Child Development Center and the Child Welfare Training Academy to name a few. Some of our most popular webinars have been panel discussions including adult survivors of child abuse, and current and former foster parents. Additional webinars have been informational in nature such as a preview of the upcoming legislative session, and an introduction to child welfare for people new to the field.
